I. Call to Order & Roll Call

IV. Changes to the Agenda

Supervisor made request to add additional agenda item to be first: Park Improvement Grant.

5. Townline 14 Road Work

Jason Gower, with support from Jim Plant, moved to accept road project proposal from the Bay County Road Commission for 2025 to overlay Townline 14 Road between Bay Mid Line to Garfield 1.5 inches of HMA for an estimated cost of \$569,441 to be shared 50/50 with Beaver Township with Williams Township's estimated cost being \$284,720.50, and authorize Supervisor and Clerk to sign agreement.

6. 8 Mile Road Work

Jerry Putt, with support from Jason Gower, moved to accept the road project request from Monitor Township for 2025 to single chip and seal over existing pavement on 8 Mile Road from Midland Road south .15 mile and from Wheeler Road to Townline 14 to be shared 50/50 with Monitor Township for an estimated cost of Williams Township's share of \$20,205.50 and authorize Supervisor and Clerk to sign agreement.
