# I. Call to Order & Roll Call

# 2. Front Parking Lot and Park Path

The front parking lot has been on the agenda for 6 years. The front will be identical to the rear lot, as far as drainage. The path in the park is 50 years old and has a lot of cracks that cannot be repaired. The combined cost would be \$432,000.00.

3. Walk-In Cooler – Supervisor

The second, from Lashuay Repair was for \$6,000.00, no lead time given. Both estimates are for the cooling mechanism to be replaced.
